**RE: Certification of the Lamoille North *Modified* Unified Union School District**

Dear Secretary Condos:

Pursuant to 16 V.S.A. § 706g, please find enclosed my certification that the Lamoille North *Modified* Unified Union School District (LNMUUSD), consisting of Belvidere, Eden, Hyde Park, and Johnson for prekindergarten through grade 12 and of Cambridge and Waterville for grades 7 through 12, is a body politic and corporate having received the affirmative vote of the electorate of the Belvidere, Eden, Hyde Park, and Johnson Town School Districts for prekindergarten through grade 12 on April 12, 2016. Pursuant to 2012 Act No. 156, Sec. 17, as amended by 2013 Act No. 56, Sec. 3 and the Lamoille North Supervisory Union Final Report and Articles of Agreement, the LNMUUSD includes Cambridge and Waterville for grades 7 through 12, based upon the pre-existing membership of Cambridge and Waterville in the Lamoille Union High School District #18 for those grades.

Also enclosed are copies of the correspondence I received from the clerks of the Towns of Belvidere, Cambridge, Eden, Hyde Park, Johnson, and Waterville certifying the votes of their respective community.


**CERTIFICATION OF  
THE LAMOILLE NORTH MODIFIED UNIFIED UNION SCHOOL DISTRICT**

I, Rebecca Holcombe, Secretary of the Vermont Agency of Education, hereby certify pursuant to 16 V.S.A. § 706g, that the Town School Districts of Belvidere, Cambridge (grades 7-12), Eden, Hyde Park, Johnson, and Waterville (grades 7-12) and the Lamoille Union High School District #18 are designated as the Lamoille North Modified Unified Union School District (the Modified Unified Union District) as set forth in this certification. Pursuant to 2012 Act No. 156, Sec. 17, as amended by 2013 Act No. 56, Sec. 3, and under the terms and conditions specified in the Lamoille North Supervisory Union Final Report and Articles of Agreement (Report and Articles) approved by the State Board of Education on January 19, 2016, the Modified Unified Union District shall provide:

- 1) Prekindergarten through grade 12 education to the students of Belvidere, Eden, Hyde Park, and Johnson because the electorate of those town school districts approved formation of a unified union district on April 12, 2016; and
- 2) Grade 7 through grade 12 education to the students of Cambridge and Waterville, based upon the pre-existing membership of Cambridge and Waterville in the Lamoille Union High School District #18 for grades 7 through 12, because the electorate of those town school districts did not approve formation of a unified union district on April 12, 2016.

Accordingly, the Modified Unified Union District is a body politic and corporate with the powers incident to a municipal corporation, shall be known by the name of the Lamoille North Modified Unified Union School District, may sue and be sued in the name of the Modified Unified Union District, may hold or convey real and personal estate for the use of the Modified Unified Union District, and shall exercise all the powers and responsibilities of a modified unified union school district in accordance with Chapter 11 of Title 16 of the Vermont Statutes Annotated and 2012 Act No. 156, Sec. 17 as amended.
